

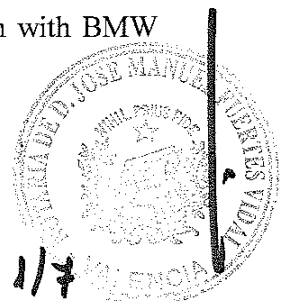

ALEC TOURNIER, being duly sworn, deposes and says:


1. I am a citizen of Switzerland and a member of Société Nautique de Genève ("SNG"), as well as General Secretary.



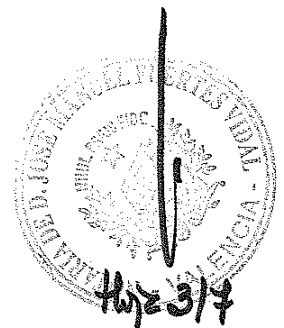

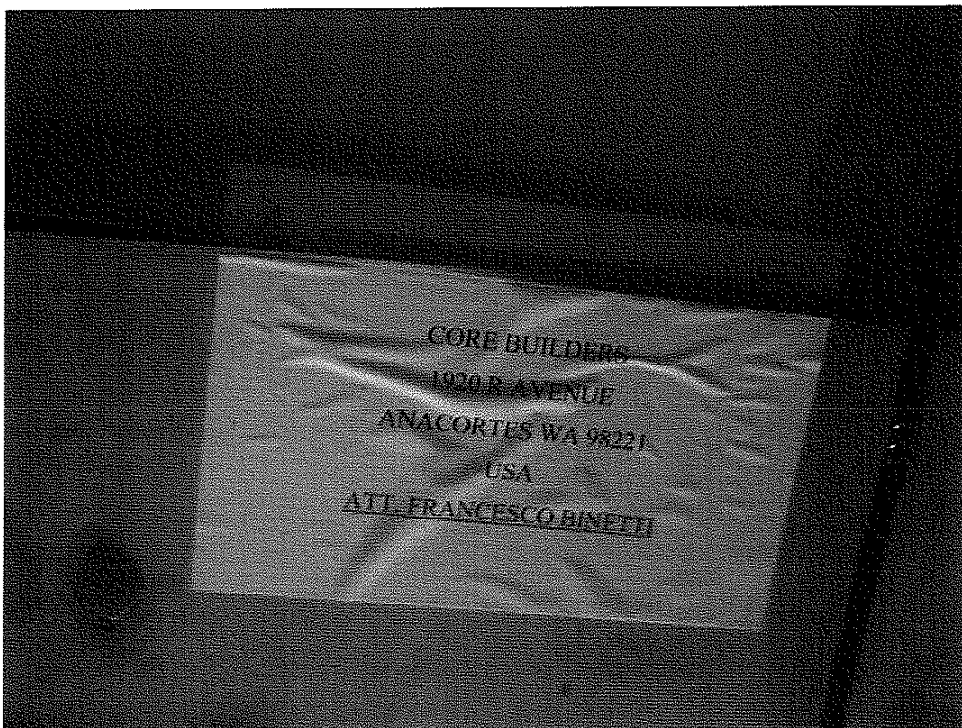
