You are required to immediately inform the Coast Guard if circumstances necessitate a change to any component of your safety plan along with your assessment on how the change affects the overall safety of your event. The Coast Guard will review any requested adjustments to your plan and supporting justifications in our assessment of overall event safety and your adherence to the conditions of this permit.

If at any point, your event becomes unsafe due to weather, vessel traffic, irresponsibility on the part of the sponsor or participants, failure to meet conditions in the Marine Event Permit, or any other reason, the USCG COTP has the authority to nullify the Marine Event Permit and stop the event. In addition please note that this permit does not allow closure of any navigable waterway or placement of unapproved buoys associated with your event.

In accordance with your Marine Event Permit Application:

- 1. The Event Sponsor shall advertise the specific dates and location of the events and use electronic/social media to the greatest reasonable extent to inform public of enforcement and securing (conclusion) of the zone.
- 2. The Event Sponsor shall coordinate with Federal Aviation Administration to issue a NOTAM for event.
- 3. The Event Sponsor shall participate in daily briefings (pre- and post-event) as requested by USCG.
- 4. The Event Sponsor shall ensure all event participants, support vessels, and helicopters under its control operate in accordance with the applicable Management and Protective Measures outlined in the 34th America's Cup Environmental Assessment, such as the marine and air buffer zones. See Enclosure 3.
- 5. The Event Sponsor shall include USCG-provided on-water traffic plan diagram and instructions on the AC34 website.
- 6. Inland Navigation Rules apply to all flagged vessels while inside the race area.

In accordance with the special local regulations established for the 2013 America's Cup sailing races under section 100-T11-0551B of Title 33 of the Code of Federal Regulations, the Patrol Commander (PATCOM), as the designated representative of the Captain of the Port (COTP), may control the movement of all vessels operating on the navigable waters of San Francisco Bay when the COTP has determined that such orders are justified in the interest of safety by reason of weather, visibility, sea conditions, temporary port congestion, and other temporary hazardous

circumstances. PATCOM may delay, shorten, or terminate any America's Cup race at any time it is deemed necessary to ensure safety.

Parts of San Francisco Bay and adjacent waterways are considered "narrow channels or fairways" by the U.S. Coast Guard. Please remind all event participants that this permit does not exempt them from following Rule 9 of the Navigation Rules, which prohibits interference with vessels that can only navigate within these areas.

For your safety and the safety of others, you must check in with Coast Guard Vessel Traffic Service (VTS) San Francisco prior to the beginning of your event and immediately after it concludes. VTS can be reached at (415) 556-2760 or on VHF-FM Channel 14 (156.7 MHz). This requirement is necessary to ensure that your event is considered as VTS Controllers continually evaluate the ever-changing traffic conditions on the Bay and adjacent waters. You must also monitor Channel 14 during your entire event so that VTS can be sure of your exact location at any time.

It is imperative that your organization maintain 100% accountability for event participants. At any time during your event, if there is not full accountability of each participant, immediately notify the Coast Guard Command Center at (415) 399-3547 and Coast Guard VTS at (415) 556-2760.

#### U.S. COAST GUARD FINDING OF NO SIGNIFICANT IMPACT FOR

### THE ESTABLISHMENT OF SPECIAL LOCAL REGULATION FOR THE 34TH AMERICA'S CUP, SAN FRANCISCO BAY, CALIFORNIA

The U.S. Coast Guard (USCG) proposes to establish a Special Local Regulation (SLR) in the Central San Francisco Bay for the proposed 34th America's Cup (AC34) sailing races. The proposed SLR would ensure that navigational and public safety is protected during the AC34 sailing races. This SLR would only be activated for the AC34 sailing events in 2012 and 2013. However, no AC34 sailing events would occur until further actions taken by the USCG were made, including issuance of a Marine Event Permit, and establishment of Safety Zones and Security Zones, as necessary for this proposed action.

An environmental assessment has been prepared which evaluates the potential environmental and socioeconomic impacts of the two alternatives and a no action alternative. The environment assessment was made available for public review and public comments were considered in the final environmental assessment. The USCG has selected Alternative C, East-West Race Course Shifted East by 2,500 feet in 2012 and North-South Race Course (Contingency).

This action has been thoroughly reviewed by the USCG and it has been determined, by the undersigned, that the proposed action will have no significant effects on the human environment.

This finding of no significant impact (FONSI) is based on the attached USCG prepared environmental assessment, which has been determined to adequately and accurately discuss the environmental issues and impacts of the proposed action and provides sufficient evidence and analysis for determining that an environmental impact statement is not required.






# America's Cup Primary Regulated Area, 2013

10a. Narrative description and geographic location of event:

The world-famous San Francisco Bay will be home to the 2013 America's Cup Finals and the Challenger Selection Series for the Louis Vuitton Cup, as well as an America's Cup World Series event in 2012. This will be the first time the America's Cup has been hosted in the United States since 1995.

The 34th America's Cup is projected to inject an estimated \$900 million dollars into the San Francisco region. Racing will be held adjacent to the iconic San Francisco Cityfront and be visible from world-renown tourist destinations such as the Golden Gate Bridge, the Marin Headlands, Crissy Field, the Embarcadero and Fisherman's Wharf. Two million spectators are expected for the Louis Vuitton Cup Challenger Series and the America's Cup Finals.

With a goal of creating the most dynamic America's Cup in history for fans and participants, changes have been introduced to the 34th edition. Enhancements include the introduction of groundbreaking new 72' wingsailed catamarans capable of speeds in excess of 40 miles per hour, new race formats and rules, and a transformed media and online broadcasting approach to enable an interactive viewer experience.

July 4<sup>th</sup> the Americas Cup Opening Ceremonies will start at 12:00 with the gates for Piers 27 and 29 opening to the public. Onshore activities will commence at 12:30 with the Airshow beginning at 14:45 lasting 11 minutes. ACRM will support the establishment of the box at 14:15 until the airshow concludes using 15 boats from it's Marshall fleet. The organized activities will conclude on Piers 27/29 at 16:30



- 11. What extra or unusual hazard will be introduced into the event area by participants or spectators?
  - USCG will manage the traffic outside the zone, and ACRM will manage the activities inside the zone
  - The AC72 vessels are at the leading edge of sailing vessel technology. A safety review has recently been undertaken of these vessels sailing on San Francisco Bay. As a result a number of requirements will be introduced to improve safety during the Event. These requirements are highlighted under the heading "2013 America's Cup Safety Requirements Version 1.1" within this application.
  - For the events of 2012, a document "On Water Instructions for Flagged Vessels October 2012" was prepared to describe the management of non-race vessels within the race area. This document will be upgraded for the events of 2013 and submitted to the USCG.
